### JOINT RESOLUTION RECOGNIZING MAINE'S CREDIT UNIONS

WHEREAS, Maine's credit unions are member-owned and member-governed financial cooperatives dedicated and committed to serving the needs of their members and communities. The not-for-profit structure of credit unions provides each member with an equal voice and representation in the operations of the credit union. Serving members in all 16 Maine counties and in every community, Maine's credit unions operate with the primary purpose of benefiting the more than 600,000 Maine consumers who use credit unions; and

WHEREAS, the economic benefit that Maine's credit unions provide to Maine consumers is approximately \$73,000,000 annually, as a result of lower and fewer fees on products and services, lower interest rates on loans and higher interest rates on savings; and

WHEREAS, Maine is once again ranked as the nation's 5th strongest credit union state based on the percentage of population that uses a credit union, a position Maine has held for 9 consecutive years. With more than 600,000 members, credit unions serve nearly one in every 2 Maine residents; and

WHEREAS, the 2,050 full-time and part-time employees of Maine's credit unions and the more than 1,000 unpaid volunteers who serve on credit union boards and committees demonstrate the core credit union values, philosophy and mission of people helping people by contributing to the communities they serve; and

WHEREAS, Maine's credit unions and their members have raised \$3,500,000 to help end hunger in Maine since 1990. One hundred percent of all money that is raised through the Maine Credit Unions' Campaign for Ending Hunger stays in Maine and goes directly to assist thousands of Maine families and individuals who otherwise would go hungry. In addition to contributing thousands of dollars to food pantries in communities across the State, Maine's credit unions also help to provide funds for statewide initiatives to help end hunger, such as being the primary source of funding for the State's only Food Mobile. In partnership with Good Shepherd Food Bank, the Food Mobile has delivered over 1,000,000 pounds of food to food pantries in every Maine county since it began in 2005; and

WHEREAS, the credit union philosophy of people helping people was extended beyond Maine's borders when, in response to the recent 7.0 earthquake that struck Haiti, Maine's credit unions started a special fund-raising campaign, "Maine People Helping People Across The Earth - A Fund For Haiti," to help the millions of people affected by the tragic event; and

WHEREAS, in 2009, Maine's credit unions contributed more than \$1,000,000 to causes including ending hunger and to a number of organizations such as American Red Cross and Special Olympics. Maine's credit unions contributed more than 25,000 hours volunteering for organizations and activities in communities throughout the State, making a significant and positive impact not only on the organizations that received this assistance, but also on the people who were served by and benefited from the services and resources provided; and

WHEREAS, since 1921, Maine's credit unions have been enhancing the lives of thousands of Maine people, who have been helped to financial success and stability. Throughout Maine, credit unions continue to play a vital economic and socially responsible role in the lives of individuals and remain a local, significant and stable presence in the communities they serve; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-fourth Legislature, now assembled in the Second Regular Session, take this opportunity to recognize the Maine Credit Union League and Maine's credit unions for their positive contributions and the significant role they have played in the lives of Maine citizens and their communities for more than 89 years. Their service and dedication to this State is a tribute to many of those values and principles that we all hold dear; and be it further

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator BRANNIGAN: Thank you, Madame President. Men and women of the Senate, this is the cell phone bill that you might have heard something about. Wireless protection for children. The reason that the Minority has put this out is that it has changed dramatically. Originally the bill called for labels, rather graphic labels, to be put on cell phones with the children's normal brain, if there is such a thing as a child's normal brain, and the children's brains having had this type of experience with cell phones. We felt the testimony was very passionate. There were people here from all over the country. We heard from people all over the country. We even had a scientist from Germany. It's a national/international discussion that is going on. What we felt, and under direction from our Dr. Mills, was that there just was not enough science yet or enough evidence yet to do something as dramatic as to put labels on the cell phone itself. The bill wanted labels on the cell phones. It wanted labels on the packaging. We thought it was serious enough to present what we were talking about to the other Body and the Senate. I don't know whether you noticed, or was able to read, a piece that was passed out a day or two ago, but the print is so fine you can hardly read it. This comes out of one of the instruction books. This was for the i-Phone 3G. All of these phones now have these kinds of warnings within their packaging, but very insignificant, although quite a paragraph here. I'll just read a little bit of it. 'This i-Phone's SAR measurement may exceed the FCC exposure guidelines for bodyworn operation if positioned less than 15 mm', about 5/8 of an inch, 'from the body.' Later it says if you really want to be careful you'll have it further from the body. In other words, if you want to have your phone out like this you are probably pretty safe. Of course you can't hear anything. You notice I carry mine in my pocket. At my age you don't hear about breast cancer. This is an issue from people who have had relatives with tumors who truly believe that they were exacerbated or caused by the cell phone that they held for many years. These are people who probably got on to these pretty early. The worry is that if there is some radiation that is going to hurt it's going to hurt young people who now have been using cell phones for quite some time. We did joke a little bit about the fact that more texting is going on now and maybe the bigger worry is tendonitis in the thumbs. We'll worry about that later. I leave the science up to our doctor in other Body who is also on the report with me. We just wanted to bring it out. Wanted to talk about it. The other Body has taken care of things, but we don't talk about what happens in the other Body. I hope you will vote as you see fit and remember this kind of warning and remember cigarettes. There were warnings by some people years ago, terribly and hard fought, by the manufacturers. The manufacturers are fighting this warning too. Thank you very much.

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Marraché.

Senator **MARRACHÉ**: Thank you, Madame President. Men and women of the Senate, I am actually on the same side as my

colleague, the Senator from Cumberland, Senator Brannigan. I am because we radically changed the bill. The bill really doesn't do half of what the sponsor had hoped for. All it does is direct there to be more information gathering and to just educate the public. It's already in their booklets. There's nothing wrong with improving the information that's out there and making it readable and easy to get to. We've been told they are updating the website. That's a great move and I think that's important. What you have on your desk as well, I passed out a two pager from the Science and Public Policy Institute. If you look on the last page it says, underlined, that there are a series of appellate court decisions, in both Federal and State courts, including a decision by the United States Supreme Court refusing to grant censure in a petition brought by the cell phone industry to bar state court actions for cell phone dangers against the industry and has directed that the states should address the issues of cell phone safety on their own. This is all this seeks to do. We haven't done anything other than to ask that there be more information and to present that to the people in the state of Maine. Thank you.

On motion by Senator **RAYE** of Washington, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Bliss.

Senator BLISS: Thank you, Madame President. Men and women of the Senate, I don't really know what to make of this. I'm old enough, as many of you are, to remember that you used to actually have to dial that big black telephone at home and if somebody wanted to reach you, and you didn't happen to be at home, they just had to wait. If you needed to make a call, and you weren't at home, you just had to wait. Things are really different now. I do know that there is one thing that we should never be afraid of in this Body and that is asking for more research. That's really what the Minority Report does now. It did away with the stickers. It did away with the scare tactics. It did away with all of the threats and all of the dire consequences. It says to the Federal government that the State of Maine wants to know what's going on and we want them to do some more research. I don't think there is anything wrong with that. I think that's a good thing. I think that's the kind of thing that Maine should lead the way in. I urge you to support the Minority Report. Thank you, Madame President.

**THE PRESIDENT**: The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS**: Thank you, Madame President. Men and women of the Senate, I rise in vigorous opposition to the pending motion. The reason is, quite bluntly, that most of the people that are promoting this dubious cause are not scientists at all. We had a parade of people that came in front of us who kept calling themselves doctors. They weren't doctors of anything that had anything of any relevance to the cell phone industry or to electronics. The kind of stuff that is being promoted as science in support of this scare deserves to be put back under the rock from which it came. There is a lot of research going on at the federal level. This sort of thing is under constant review and analysis but there is no scientific evidence at this juncture to prove, or even to suggest, that using a cell phone is going to cause brain cancer. It

just doesn't connect. There has been study after study on this and there is no support for it but there are some people out there who have allowed themselves to become completely obsessed. to a degree that I can't even begin to describe to you, that these things are the next cigarette scare, that this is solidimide over again, or something looming on the horizon and there is something evil and mysterious going on that is emanating from your cell phone every time you use it. They are groping to get government somehow involved in their cause to give it the legitimacy that it totally lacks in the scientific community. They are desperate to the point where they have handed out a flyer where they record a number of actions that have been taken by governments across the world where they have somehow convinced states or countries, as they are now trying to convince this legislature, to dignify their cause by passing any piece of paper that might give legitimacy to their arguments. Well they made the mistake of handing out a briefing book called The Campaign for Safer Cell Phones. It's got the picture of a six-yearold blond girls holding up a cell phone and looking very worried about her future. On page 8 there is a report that was made by the Human Services Committee outlining action taken by the State of Maine in the United States. Its says that in 2009 an emergency bill requiring warning labels on cell phones unanimously passed a committee of the Maine State Legislature. The proposed bill provided that a manufacturer, 'May not sell at retail in this state, or to a retailer in this state, a cellular telephone unless,' and goes on to describe a packaging and warning label system. It goes on to say that a violation of this provision is a violation of the Maine Unfair Trade Practices. It has a copy of the sticker. This is a complete fiction. We never took any such action. Indeed, when the bill was presented to us just a few weeks ago, there was anything but unanimity on the issue. They are capable, apparently, of completely fictionalizing legislative activity, to say nothing of science, and presenting it as fact. The federal government, the FCC, the CDC, and all these people that we pay large sums of money to to do scientific research have concluded that there is absolutely nothing behind this assertion about cell phones. Yes, of course it deserves to be monitored like all of the other risks that we encounter from day to day in our society. I think there is a risk somehow that maybe one of those lights up in the ceiling may fall down and bonk one of us on the head. Are we going to put a warning label up there saying 'Warning, Don't Stand Under the Light'? We can't burden our society with all sorts of false warnings. If you go to a real estate closing, and have the stack of paper in front of you that the government has compelled us all to sign off on, warning about all sorts of things that may happen to us as we go through the transaction, does anybody even look at them, let alone read them? Is it the idea that we should now ask the Center for Disease Control in Maine to embark on an educational campaign that they themselves don't believe in, but we're going to compel them to conduct the educational campaign anyways and teach false science just because we, the legislature, declare that they should? We should follow the good guidance from the other Body and reject the pending motion. Thank you, Madame President.

Senator PERRY: Thank you, Madame President. Ladies and gentlemen of the Senate, I'd like to tell you just a few things about this bill. It is a bill I sponsored having to do with school consolidation, as you can all see from the title. I represent both Bangor and Hermon here in the State Senate. School consolidation has been an issue that I wasn't that closely related to as far as the areas I represent because Bangor was already at a size and performance level, as far as efficiency, so they weren't really included in a lot of the obligations of school consolidation. Hermon, on the other hand, had been receiving students from their neighboring towns for 50 years or more and it looked like we had a natural fit for Hermon to consolidate with Levant and Carmel. As they got into it we found that Hermon was kind of isolated, not in the way some rural parts of Maine or islands here in Maine are, but kind of more economically isolated. Hermon, who neighbors Bangor, was in the Bangor labor market. The two other towns they were looking to consolidate with, the next towns over, were not in the Bangor labor market. They were in a much lower labor market. By bringing these towns together it was going to drive up costs for everyone. That is just some of the problem. They have tried to find a way to make it work. There are not a lot of available partners there. They are still committed to moving forward and making this work. It's cheaper to take the penalty than to consolidate in a fashion that does not work. I'm hoping that as we move forward we can find alternatives for them because I am realistic about what the result of this bill is likely to be. In fact, I'm not even going to request a roll call. I just wanted you to know a little bit about what's going on in Hermon. They are trying. It's just not a good fit out there for them. Thank you.

This is a very important piece of legislation for us to pass because firewood could be a real problem for us here in Maine, especially imported firewood from out-of-state. I know the good Senator from Androscoggin did speak about this legislation earlier this week, I believe it was, and mentioned about the insects that are a problem outside this state. We need to prevent them from coming into the state. I know the good Senator from Androscoggin mentioned the Hemlock Woolly Adelgid. That is one insect that is in Maine and needs to be controlled. It's not very prevalent in Maine. There are two insects that are really involved, or could be, with the importation of firewood from out-ofstate. I put information in your mailboxes on these two insects. One is the Asian Longhorn Beetle and the other is the Emerald Ash Borer. Both of these insects are not found in Maine as of yet but they could come into Maine on firewood that is being imported into Maine by campers coming in during the Summer. There are two areas outside of Maine, especially where the Asian Longhorn Beetle is. One is Worcester, Massachusetts. In Worcester, Massachusetts the Asian Longhorn Beetle was found a couple of years ago. Since then they have lost over 20,000 shade trees in Worcester, Massachusetts. There is a large area, I can't remember if it's 28 square miles within Worcester that is quarantined. It's a real problem down there. Worcester, Massachusetts is not that far from Maine. It is a real primary concern and I just wanted you to be informed about these, especially these two insects. This summer, if you are looking at firewood that may be coming in from outside the state, the legislation says that is outlawed right now. Thank you.

I know that I have received a number of phone calls and e-mails regarding this legislation, L.D. 1781, from people who conduct genealogical research, concerned that this is putting new limits and also perhaps making documents that have been available to them unavailable to them for as long as 100 years. I wondered if I could pose a question through the Chair to anybody who may wish to answer it and address those concerns?

**THE PRESIDENT:** The Senator from Washington, Senator Raye poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Oxford, Senator Hastings.

Senator HASTINGS: Thank you, Madame President. Ladies and gentlemen of the Senate, this being an issue that was at least considered by the Judiciary Committee in connection with the requirement that any proposed new exception to the Freedom of Access Law come to our committee for consideration. Our excellent analyst has done a very detailed study of this and has come to the conclusion that if anything this bill may even slightly open access to public records. I think there has been a lot of misinformation about this, so I'll tell you briefly what our analyst has come up with. Under the current law, the law requires or establishes a general restriction that limits access to individually identifiable data, elements of vital records, to those persons who can demonstrate to the department's satisfaction a direct and legitimate interest in the subject matter. That is the current law and it is not being changed. What the current law does with respect to the vital records is two things. First, the current law allows the person, and the attorney or agent for that person, who is the subject of the record access to the entire record. The bill expands that list to include spouses, domestic partners, descendents, parents, and guardians. Second, the bill provides records are public records open to everyone after 100 years. That does not exist now. As was mentioned above, the current law authorizes access to vital records to anyone with a direct or legitimate interest in the matter recorded. That has been handled by department rules which are not going to change in any way what so ever. Probably the section of the rule that has caused the most consternation is the existing rule which says that inspection may be had by those individuals conducting health, medical, and social research, including those in governmental agencies. I think the department has considered genealogical individuals making those studies as being under social research. Based on our analyst's investigation, the department has no intention whatsoever to change those rules or their application of the rule, so although I certainly love having fun with more exceptions to confidentiality, this one does not do that and I think I can speak for the committee that this is the case.

**THE PRESIDENT**: The Chair recognizes the Senator from Washington, Senator Raye.

Senator **RAYE**: Thank you, Madame President. May I pose another question through the Chair?

I'm just wondering if we could be, through this legislation, imposing a new requirement on those who conduct that research?

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Bowman.

Senator **BOWMAN**: Thank you, Madame President. This bill, L.D. 425, requires individual group health insurance policies and all HMOs to provide coverage for the critical early intervention services, that is critical meaning birth to 3 is vitally important not only in this bill but in many others that you have heard before. I don't think I need to go into that criticality. This requires that after referral from a primary care provider for children birth to 3 years, if the child has a developmental disability described under the Federal IDEA, which is the Individual With Disabilities Education Act, it limits coverage to \$3,200 per year times three, or \$9,600 at the end of age 3. It shifts funding from MaineCare to insurance premiums, thereby saving state taxpavers some money. The impact on the premium is 18¢ per member per month. Let's take an example; 3 people in the family, 3 times 18 is 54¢ per family per month times 12 is about \$6.50 per family per year. Nine other states have similar laws, including most of the New England states. They are New Hampshire, Massachusetts, Connecticut, and Rhode Island. I would urge you to vote to pass L.D. 425. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN**: Thank you, Madame President. Men and women of the Senate, this removes the fiscal note to the bill. It is something we thought we had done but we actually had done the exact opposite. It is only for those petitions that are questionable by the city or town clerk that's looking at it that they needed to be copied. It would avoid some of the things we've had happen before in Leeds and other places. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator **TRAHAN**: Thank you, Madame President. This language, as currently in this amendment, was in a previous amendment that I had, so I would hope that the chamber would support it without too long of a debate and roll call even. I just wanted to say that I'm in support of the amendment.

On motion by Senator **SULLIVAN** of York, Senate Amendment "B" (S-481) to Committee Amendment "A" (S-443) **ADOPTED**.

**THE PRESIDENT**: The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator TRAHAN: Thank you, Madame President. Ladies and gentlemen of the Senate, prior to the debate that we are having today I purposed an amendment to this legislation. I hoped to improve it. You remember my testimony from the debate earlier. I just have some concerns with certain elements of the amendment. I presented that amendment to leadership on the other side of the aisle and there was some confusion on what was in that amendment. What I did was, in order to get rid of that confusion, I separated out the things that were contentious with the things that we seemed to have in agreement. That is the amendment that is before you. What this amendment would do, and I think why it is important, is that as we adopt the unique identifier for each petition I think that may be helpful to both the Secretary of State and people on both sides of these issues. Unfortunately, the way that the bill is drafted it would require a unique identifier on both the top and bottom of every page of a petition. A petition could be ten pages long and that wouldn't be unusual. It would require a signature gatherer to put a unique identifier at the top and bottom of, let's say, a ten page document twenty times. They may have 100 petitions. That would mean that they would have to do this 2,000 times. It would be very cumbersome. I don't think it's necessary. I think the unique identifier should be only on the pages that hold signatures and that is what this amendment would do. I don't believe we need a unique identifier on a number of pages of nothing but the bill itself or the explanation of the bill. There is no real reason to do that. That is one thing that it would do. The second thing that it would do is, under this current amendment you would have to have your petitions notarized before turning them in to be certified. This

would just require the registrar or the clerk, if it hasn't been done, to give it back to the people when they turn it in. That way it wouldn't put any responsibility on the clerks to do anything other than that. I believe that these two items were agreeable and were oversights, at least that was the way it was described by leadership and the chair of the committee. I'm hoping that we can support this amendment.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN**: Thank you, Madame President. It is true that originally, through some confusion and the heat of the time, these two things were agreed with but there were other things that totally were out of the issue of fraud and we did not want them. With the understanding of the sponsor of this one, I would ask this Body to accept this amendment and move on.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Nutting.

Senator **NUTTING**: Thank you, Madame President. Permission to pose a question through the Chair?

**THE PRESIDENT:** The Senator may pose his question.

Senator **NUTTING**: Thank you, Madame President. When I read the front of S-487 it looks agreeable to me as a sponsor of the bill. However, my question is, when I read, as I just did a few seconds ago, the fiscal note on page 3 the fiscal note says that this amendment removes the requirement for the businesses that are running a paid signature gathering effort to register with the Secretary of State. That wasn't agreed to. Maybe I'm reading this wrong, but my question I'm posing is what is the real meaning of what is stated in this fiscal note section? That's very alarming to me. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Nass.

Senator **NASS**: Thank you, Madame President. Ladies and gentlemen of the Senate, after last night's debate I just got more and more concerned about what we've done. I just can't imagine we're tying the bonded labor dispute, and it's been ongoing and I'm sympathetic and all that, to Tree Growth. I don't understand and if I can, Madame President, pose a question through the Chair?

**THE PRESIDENT:** The Senator may pose his question.

Senator **NASS**: Thank you, Madame President. I don't understand how we can use a State tax program, which is Tree Growth, to punish an individual entity or other corporation, which is largely the landowners, for participating in a legal federal program. What are we creating here, I guess is my question, Madame President.

**THE PRESIDENT:** The Senator from York, Senator Nass poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator BARTLETT: Thank you, Madame President. There are many federal laws in place that allow people to do all sorts of things. It doesn't require the State of Maine to give a tax incentive to support it. The purpose of the State of Maine providing tax incentives, which is a shift in resources from other taxpayers in the state of Maine to those individuals, is to promote things that we think are worthy of it, that we think have strong economic value, that may create jobs, or may have other value to the state as a whole. When the landowner is bringing in labor from another country, giving them advantages over our own people when we have 900 plus loggers looking for work, the State of Maine has no responsibility to extend tax benefits to support that effort. It doesn't help the people of Maine. We should limit our tax programs, our tax exemptions, and the resources we are putting into those to businesses that are helping support Maine people. That's what this is about. Thank you.

On motion by Senator **COURTNEY** of York, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The Chair recognizes the Senator from Franklin, Senator Gooley.

Senator **GOOLEY**: Thank you, Madame President. A very short response to the previous remark about the Tree Growth Tax law. The Tree Growth Tax law is not preferential treatment. It is treatment for current use. Current use in those forests up north, that's all they are ever going to be is growing trees. It's for current use. It's not preferential treatment. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Nass.

Senator **NASS**: Thank you, Madame President. Again, I'd like to pose another question through the Chair.

**THE PRESIDENT:** The Senator may pose his question.

Senator **NASS**: Thank you, Madame President. First, just a brief statement. In the beginning Tree Growth, for especially the large landowners, was not voluntary. They were forced into it. Again, understanding that and the fact that almost every year the rules of the game have changed for Tree Growth. God knows they struggled down in the Taxation Committee to satisfy the various elements of this. We continue to change the rules to the detriment of the program. It's our biggest conservation program. We keep changing the rules. Those people who are in it, and those people who were forced into it, have no way to get out except by paying a huge penalty. My question, I guess, is that there is no place for them to go without a huge financial penalty so what are we to tell these folks when they can't comply, financially, except by paying huge, significant penalties? What options do they have? Thank you.

**THE PRESIDENT:** The Senator from York, Senator Nass poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON**: Thank you, Madame President. Ladies and gentlemen of the Senate, I would say hire Maine people.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN**: Thank you, Madame President. May I pose a question?

**THE PRESIDENT:** The Senator may pose her question.

Senator **SULLIVAN**: Thank you, Madame President. It is my understanding, and I need to know if it is correct or not, that if these people from Canada are laid off they collect United States unemployment.

**THE PRESIDENT:** The Senator from York, Senator Sullivan poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON**: Thank you, Madame President. Ladies and gentlemen of the Senate, it is true that currently bonded labor is allowed to file for unemployment at the end of the season and receive it even though they are in Quebec or New Brunswick and the Maine Department of Labor has no ability to track if they are working or what they are doing. The Maine Department of Labor has no ability to know. It's also part of the issue that when you sign the unemployment card, the very first question on it there is that you are saying that you are available and willing to work every day of the period that you're asking for the unemployment for. I would think that one of the ways that you would be available

is if you would be allowed to be in the country, in the United States. During that time your bond has run out, so you have no legal ability to be in Maine or the United States during the period that most people draw unemployment. Mud season. Up until the State of Maine has allowed that to happen. We have another bill coming that will restrict that. Last year \$500,000 in unemployment benefits were taken out of the Unemployment Trust Fund but the employers that were employing the bonded workers had only paid in \$200,000 to the Trust Fund. The extra \$300,000 was picked up by the other Maine employers in the State of Maine. They basically paid for the unemployment of these foreign workers. Obviously next week sometime we'll take that issue up, but they can have unemployment currently and I'm sure, coming up here, many of them will be taking advantage of that.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Sherman.

Senator SHERMAN: Thank you, Madame President. Ladies and gentlemen of the Senate, I don't know how many people have land in Tree Growth. I have some land in Tree Growth. The original purpose of this was to make sure that the land was not subdivided and sold, among other things. I don't have very much in it, but when I'm sitting here listening to some of this conversation I get irritated. Maybe that's for a show of hands. How many other people are in Tree Growth? There was an amnesty a few years ago about getting out of Tree Growth. They would pay big bucks to get out of it. I happened to buy some land from my brother. He was smarter than I was to get out of Tree Growth. When I first came down here I can remember going up on the 4<sup>th</sup> floor and people were hectoring about Tree Growth then. What bothered me was, because I was in Tree Growth, I kept hearing 'Our land, our land' because we had a dollar bill or two dollar bills in there, whatever it may have been. I looked into getting out last year. I sat down and figured back taxes with some inflated value. In some ways I ought to sell it for what I could. I don't want to do that. Some of it is a place where house lots could be. We keep it for a small family business. We do sell some material off it. When I hear that the State has interest. that's how State programs grow. All of a sudden they start out in one track and end up in another. They are using this now as a punishment. I wish I had a tape recorder of all those things I've heard over the last ten years. It's just another way to get at individuals, I think. In terms of the big landowners, some of those folks I've bumped into over the years. We used to have a number of lumber contractors in the Houlton area. Guys that really had a few million dollars in their checkbooks who now have been squeezed out for a number of reasons. Some of them are still in business. When talking to them about getting out of Tree Growth, in some areas if you are in the middle of a huge forest, Tree Growth doesn't amount to much. The big taxes are down on the coast with all of those \$2.5 million homes down there. You take a piece of property and put it in Tree Growth you know it's never going to be cut or used for anything. Again, we're putting a broad brush across the state. We're using Tree Growth in a way that is a punishment. It was never intended to be that. It didn't take too long to morph into that. This is another one of those sad conversations we have about people having very short memories about what the intent was of certain things when they got started. Thank you for listening.

**THE PRESIDENT**: The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS**: Thank you, Madame President. Men and women of the Senate, by way of further answer to the question posed earlier, in order to qualify for unemployment benefits you have to work, I believe, in two consecutive quarters. I think it is not common for bonded labor to qualify for unemployment, although some of them obviously do. The second thing is that we had a bill in the committee where we were unanimous, as I recall, in our view that the unemployment law ought to be amended. Indeed there will be that opportunity in a bill that will be presented to the legislature next week. I think that is the appropriate place to deal with that separate issue. Certainly the Tree Growth Law shouldn't be used to remedy a problem in the unemployment law.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator **SCHNEIDER**: Thank you, Madame President. Men and women of the Senate, the way the businessman in my Senate district, who is in this business, looked at this is as a choice versus some sort of a punishment and that people would now have to make that choice about whether or not they hired bonded labor or were in Tree Growth. Thank you.

**THE PRESIDENT**: The pending question before the Senate is Enactment. A Roll Call has been ordered. Is the Senate ready for the question?
