## JOINT RESOLUTION RECOGNIZING APRIL 2023 AS SECOND CHANCE MONTH

WHEREAS, every person is endowed with human dignity and value; and

WHEREAS, redemption and second chances are American values; and

WHEREAS, almost 2,000,000 Americans are currently incarcerated; and

WHEREAS, individuals returning from prison and those who have paid their debts after committing a crime face a "second prison" of stigma and obstacles, also known as collateral consequences; and

WHEREAS, individuals with criminal histories encounter significant barriers such as an inability to find housing, employment or education, regain voting rights, volunteer in their communities, secure identification documentation and pay off substantial financial debt accrued as a result of conviction and incarceration; and

WHEREAS, these barriers can contribute to recidivism, which increases victimization, decreases public safety and results in lost human capital and economic output for communities; and

WHEREAS, as of 2023, approximately 1,650 individuals in Maine are incarcerated in a Department of Corrections facility; and

WHEREAS, the designation of April as Second Chance Month can contribute to increased public awareness about the "second prison," the need for closure for those who have paid their debts and opportunities for individuals, employers, congregations and communities to extend second chances; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to recognize April 2023 as Second Chance Month, and we urge citizens to observe this month through actions and programs that promote awareness of the "second prison" and provide closure for those who have paid their debts.

Senator LIBBY: Thank you, Mr. President. Mr. President, I just wanted to make a few comments about this bill. I appreciate the fact that we're asking for a study committee here. One of the major concerns that I think should be explained regarding those who did not support the bill is that the American - the National Association of School Psychologists is very much opposed to and have written some articles on the kinds of training that are discussed in this particular bill. Lockdown regarding gun violence training probably does need to be explored so I don't blame any of those that voted in favor of the bill at all for their position. However, there is a large number of theorists, writers in the field, and others who feel that this practice would cause great trauma on children and I think the folks in committee who voted - who opposed this bill, including me, felt like we needed some more time to think this entire process through. More research, more data on the effect, the potential effect on children, and the trauma that it might cause to have active shooter lockdown drills in schools. Thank you very much, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Rafferty.

Senator **RAFFERTY**: Thank you, Mr. President, and thank you, Senator Libby, for your comments. I just want to clarify at this time. So, this, essentially, is for us to have an opportunity to study the best practices and at the time there was an amendment made so that if schools knew in advance there was going to be a lockdown drill around active shooters that the word would be out and it does give parents an opt-out option currently and then it will allow us to have extended study in terms of the best practices overall. Thank you very much.

So, nobody in the hydro industry spoke that said that this was a needed bill. It's not something we need to do, it will not help us bring more hydro power into the state of Maine, so I ask you to vote Ought Not to Pass.

Senator LIBBY: Thank you, Mr. President. Men and women of the Senate, I rise today to talk to you a little bit about the private market and the public market, and I sometimes feel in the 131st that the private market is completely ignored and I want to make sure that I explain exactly what I mean by that. I think it's an important principle to ask yourself the question if you're providing a credential of value to a community college student, great idea, can't - can't argue with that. We want that education. You have to ask yourself the question who's picking up that cost now. Who's picking it up now? In the case of this bill, we'll be - the taxpayer will be picking it up and it's at a cost of \$5 million in the first year of the biennium, \$5 million in the second year, for a total of \$10 million. We in the Education Committee who voted against this bill felt like it was important for us to establish priorities. The priorities are what can we spend money on and then we use the normative question what should we spend money on and then we try to compare the two and come to a conclusion, and the conclusion with this bill was that it's hard for the privates who are competing for the same student that the community college recruits, it's hard for them to beat free. We already have a free community college program. It's picking up cost and I'm impressed that that's the direction that some people want to take. I don't agree with the direction but I understand it and I appreciate it. But how many more steps are we going to go in terms of the taxpayer picking up credentials and, frankly, many other items that we've been sorting through in the Joint Standing Committee on Education. These are all really good ideas and maybe this is the year we got - that we have a lot of funds. Is it sustainable? Are these spending matters that are coming to us, are they sustainable? We're not binding the 132nd - thank you - we're making our own decisions and maybe they'll come in and they'll make the harder decision, the harder but the better decision about who should fund these sorts of things. So, the free community college argument, the shift to the taxpayer argument, these are the arguments that we're trying to make and, finally, the determination of, given a limited supply of dollars, what do we need to - what do we need to purchase for students in Maine versus what would be a good idea but we maybe shouldn't and don't need to? Thank you, Mr. President, and I hope that the members will support me and the Ought Not to Pass. So, oppose this. Thank you.

Senator **RAFFERTY**: Thank you, Mr. President. As you can easily hear this morning, there are some difficult decisions being made surrounding education. But we have made a commitment to the community colleges and L.D. 447 is a commitment to those students because it will provide some funds that are going to provide resources for their success. Between navigators, position

of mentors, and availability of people in the learning common areas, there is nothing hidden in this, it's all about supporting those students. It's is very difficult life to be a community college student. Oftentimes, these people are running parallel in their other world in terms of workforce. Many of them are - it involves a real commitment on their part and we have made that commitment as a legislator. You know, having sent three of my own daughters to private school education, you know, that was very difficult for us. But I'm not here - I'm not in a position today to provide any relief for private schools nor tell them what they can do. I'm just really here to make sure - we've got this investment made into community colleges, we want to see it through, and we want to see nothing but success for those students. So, I urge you to support the passage of L.D. 447. Thank you.

Senator MOORE: Thank you, Mr. President. I - this bill is addressing the membership of the Permanent Commission on the Status of Women. Prior to my election as Senator, I proudly served on this commission and I saw a lot of good work that was being done throughout the state and it continues to be done today, not just because I left the commission. But the commission itself was established to really - to have members who had knowledge of problems facing the women in the state, who had experience or have experience in advocacy relating to women's issues, and who provide leadership in programs or activities that improve opportunities for women. The members are chosen from across the state in a varied background. It outlines it in the statute across all different realms of it. My concern about this particular bill is that it is adding two additional positions to the commission and I'm feeling like it is becoming a mission creep and moving away from the initial grounds that we set this commission up and the work that we were doing for women. So, I oppose this and will vote against it. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Sagadahoc, Senator Vitelli.

Senator VITELLI: Thank you, Mr. President. Men and women of the Senate, I, too, had the honor of serving on the reconstituted Permanent Commission on the Status of Women and Girls along with my Senate colleague and we did do good work, albeit without any staff resources. So, one of the important things that this bill does is to provide, for the first time, modest funding so that the commission has the capacity to collect, assemble, and analyze the data on the experiences of women and girls throughout the state and be able to provide that information to those of us who are here as policymakers. As we all know, in order to evaluate the effectiveness of our policies and our programs, it's helpful to know what's happening on the ground and that's exactly what the Commission for Women and Girls is intended to do and it's been trying to do on less than a shoestring since its initiation, or reinitiation. In terms of expanding the membership of the commission, I think, again, there's a modest request to add a couple positions to better reflect the full breadth of experience of women and girls in this state and I think it's appropriate that women's lives and girls' lives, whatever path they're taking, are represented on this commission and that their voices are heard. In particular, one of the positions is for a young person and I

think, given that our state tends towards the older end of the spectrum, it is even more important that we have a youthful voice on this commission because they are the future and we want to make sure that their reality and their concerns are adequately addressed on this commission that is looking at aspects of their lives including education, health and safety, the economy, their leadership potential, there's so many aspects of what women and girls do and contribute in the state that we need to be able to keep tabs on what's happening.
