On motion by Senator **POULIOT** of Kennebec, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from York, Senator Woodsome.

Senator WOODSOME: Thank you, Mr. President Pro Tem. This bill, L.D. 1820, will expand the University of Maine Board of Trustees by three members, all of whom would be University employees that the Governor would have to pick from a unionprovided list. For nearly 50 years state law has guarded against trustees of any state office or public institution from having real or perceived conflicts of interest. For example, employees of the Maine K-12 districts, and even their spouses, cannot serve on the school board. L.D. 1820 would undo that important Maine tradition, undermining the trust and confidence the public should be able to have in their board of trustees for our state's largest public education system, the University of Maine, by requiring a board of trustees be expanded to include three seats from three current employees essentially hand-picked by the unions. Last year, Governor Mills did the right thing and vetoed a similar bill. L.D. 1820 attempts to sidestep the concerns about conflict of interest that the Governor raised in her veto message by making

employees trustees and non-voting members. But the conflict and the perception of conflict remains. Current University policy states that trustees cannot participate in discussion about agenda items which may benefit them or their family more than the average Mainer. Employee compensation makes up more than two-thirds of the University's budget and budgetary matters are at the heart of nearly all of the board's meetings meaning employee trustees would need to constantly recuse themselves. There are already faculty from each university, selected by their duly elected faculty senates, who serve as representatives to the board and are regularly invited for input to inform the trustees of important work. Having employees on the University board is a slippery slope and it's unnecessary which is why Trish Riley from the University board and the Honorable Joyce Maker from the Community College board, both appointees of the Governor, testified before the committee on behalf of their respective boards against this bill. I'll close with the words of the Governor in her veto message, 'It is bad policy, bad public policy, to require active employees to serve on a board that makes decisions that sets their salaries and otherwise directly impacts them.' I urge you to vote no on L.D. 1820. Thank you.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from York, Senator Rafferty.

Senator RAFFERTY: Thank you, Mr. President and thank you, Senator Woodsome. We both serve in the same committee but we come at this from opposite views. I view this as a great opportunity for the Board of Trustees to gain significant insight from non-voting members - of these added non-voting members to the board. They would represent faculty, non-faculty, and adjunct faculty and I think that they, again, offer tremendous insight as they are stakeholders in the University and over the terms of years, if you look closely at a lot of these boards, board members come and go but it seems pretty consistent that faculty members remain, most for 35, 40 years and above. So, I think they offer a great opportunity for the board and, again, keep in mind they are non-voting members. They can offer views and they also are not allowed, or will not be allowed, to vote on anything that might directly impact their particular job and they are not in executive sessions of the board. Currently, if a person, a teacher or faculty members, non-faculty member, wanted to address the board they could sign up in advance to speak at their meetings but they had very limited time and their comments are not recorded in the minutes. Again, I think this is great opportunity for stakeholders on both sides to benefit greatly from the knowledge and experiences of these three members. Thank you.

I want to point out again that this is another one of those bills that we are trying to put salaries or compensation into statute. This particular one is that. I applaud the work that our intensive case managers do and I know it's very stressful and I know they do really good work. However, this bill is trying to give them a \$5 per wage hour stipend and an additional \$1 per wage hour stipend for employees holding or obtaining a relevant Master's degree. Again, they are union.

They have union negotiations that are always going on. I really feel that we, as Legislators, should not be directing the Department on salaries. That should be done at the negotiating table. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Claxton.

Senator **CLAXTON**: Thank you, Mr. President and ladies and gentlemen of the Senate, I rise in support of this bill. I share the good Senator Moore's frustration with having to deal with these bills in committee but I also understand that sometimes the negotiation process doesn't work the way it's supposed to, has broken down, and that people, for a very long time, have the option to come to the Legislature to seek redress of their concerns and to try and get adequate compensation. So, while I agree with many aspects of what Senator Moore has offered, I think in this instance there's been documented evidence of the difficult circumstances under which these intensive case people who work at Dorothea Dix and Riverview function and, for that reason, I will be supporting this bill. Thank you.

So, that's the reason why I'll be casting a vote in opposition to this bill and also we have another bill that pretty much is going to be putting about \$27 million into the Home Fund. So, I think that's a good start for this year with Senator Chipman's bill that we'll be voting on in the future. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator CARNEY: Thank you, Senate President. I rise to speak in favor of the pending motion. L.D. 1357, An Act to Require Private Insurance Coverage for Postpartum Care, would provide urgently needed health insurance coverage to align insurance policies issued in Maine with current medical recommendations related to postpartum care. Complications following childbirth include pain and bleeding, high blood pressure, lactation difficulties, and pelvic floor disfunction. For example, more than one-quarter of U.S. women have pelvic floor disorder with symptoms such as long-term urinary incontinence. Treatment, like physical therapy, can strengthen pelvic floor muscles and improve quality of life. Private insurance coverage for postpartum care though is very limited and doesn't cover this and other necessary medical care. In fact, most insurance policies provide coverage based on an out dated and insufficient framework for postpartum care involving just one visit at six weeks postpartum. The American College of Obstetrics and Gynecologists has adopted a new framework for postpartum care as an ongoing process rather than a single encounter, with services and support tailored to the patient's individual needs, including an assessment within the first three weeks postpartum to address acute needs and following up with ongoing care as needed, concluding with a comprehensive well-woman visit no later than twelve weeks after birth. Unfortunately, many health insurance and reimbursement models conflict with this new framework for postpartum care and drive healthcare providers and patients to that single office visit at six weeks. This is simply not adequate to treat things like pelvic floor disorder that require ongoing physical therapy and the many other medical issues, like postpartum depression, high blood pressure, lactation difficulties, and sometimes serious cardiac issues, that can arise. L.D. 1357 would require private insurers to shift from coverage based on that single six week visit to coverage that aligns with the recommendations of the American College of Obstetrics and Gynecologists. This shift will improve maternal health outcomes without significant premium increases. The three months following the birth of a child are wonderful and challenging. New moms are recovering from childbirth, caring for an infant, sometimes navigating other health conditions, and simultaneously preparing to return to work at the end of twelve weeks of family medical leave. Insurance coverage that allows women to get the postpartum care they need will allow Maine women to successfully transition to parenthood, stable health condition, and return to work. I thank my colleagues for supporting the Ought to Pass report.

As you deliberate, I ask that you use compassion and basic common sense and, as is contained in the verbiage of the bill, fund and support these veterans' homes, thereby reversing a decision that no entity should ever have been empowered to make without Legislative approval. Passage of this bill requiring the Department of Health and Human Services to allocate emergency payments to these facilities is critical. It is my opinion that every effort should be sought in addressing continued funding and adequate staffing options before any action for closure be entertained. These facilities continue to provide services that are vital to our veterans and their quality of care is second to none. My strong apprehensions of this action range from the effect it will have on our most vulnerable veteran population and their families, to the potential domino effect this action could play in the

future of any remaining veterans' homes located throughout the state of Maine. Although I do not reside in the areas of the proposed closures, I speak directly to the need for these facilities to remain open. My parents served proudly in the Marine Corp during WWII. Several years ago, my brother and I, following our father's surgery and the necessity for further rehabilitation, faced the difficult decision to locate a facility that we felt would best address his emotional, as well as physical, needs. Sadly, there were no beds available at the MVH at that time. The alternative was a nursing home that was not only a great distance from home but one that turned into a less than satisfactory situation and subsequent closure, resulting in our being forced to remove Dad and resume care ourselves. Years later, we faced another agonizing decision to seek a skilled nursing home with provision for long-term care for our mother. Fortunately, she was admitted into the Western Maine Veterans' Home where she was treated with the utmost respect, remained happy and content, and received the highest level of care until her death three years later. I share these stories as an example of the importance, not only to the dignity of veterans in allowing them the opportunity to connect with those who they can relate and familiar surroundings but also in helping to lessen stressors like that of being relocated and often distanced from their families. When the Veterans' Homes were first established in 1977, the people of Maine made a commitment to our veterans. I ask that you remember that our most important mission and promise to our veterans should remain in providing quality care options when and where they need it. It is my hope that you will explore all available options on this important issue and help in developing a long-term plan to keep these facilities operating effectively and efficiently. Our veterans and their families deserve no less.' I agree with Gerry Brooks Greenwell of Bethel, Maine.

The committee listened to her and others and we drafted a committee amendment that would strike and replace the implement in statute to clarify the policy and intention of the State and the Legislature as follows: it is the policy of the State to ensure the provision of long-term care, support, and services to eligible veterans and their family members in every region of the state and it is the intent of the Legislature that the Maine Veterans' Homes implement this policy by providing long-term care, support, and related services to fulfil the State's moral obligation to promote the wellbeing and dignity of the veterans who have served their nation, often in times of war and at great cost. The primary purpose of the Maine Veterans' Homes is to provide support and care for honorably discharged veterans who served on active duty in the United States Armed Forces or who served in the Reserves of the United States Armed Forces on active duty for other than training purposes and for any other class of veterans who meet applicable State and Federal requirements to receive services provided by the Maine Veterans' Homes. To carry out the duty of providing long-term care, support, and related services to eligible veterans and family members of veterans, the Maine Veterans' Homes must be located in Augusta, Bangor, Caribou, Machias, Scarborough, and South Paris. The Homes located in the municipalities listed in this subsection must remain in continuous operation and no location may discontinue services until the Board of Trustees of the Maine Veterans' Homes follows the process established in Section 612. Among other things, Section 612 reads as follows: if the board authorizes the discontinuation of services at or the closure of a public home for veterans the board shall notify the President of the Senate, the Speaker of the House of Representatives, and

the Joint Standing Committee of the Legislature having iurisdiction over veterans' affairs within three days of the authorization and no less than 45 days before submitting a plan for the discontinuation of services or closure of the home to the Department of Health and Human Services if required by law. Within ten days of receiving notice under this section, the Joint Standing Committee of the Legislature having jurisdiction over veterans' affairs, with as much public notice as possible, shall hold a public hearing at which board members shall present the reasons for the discontinuation of services or the closure and the committee shall accept public comments on the discontinuation of services or the closure. At that public meeting, the board shall present financial and demographic data, the board's plan for care of veterans receiving care at the home, and the family members of those veterans, and the board's plan for the use or disposition of facilities after the home is closed. The Joint Standing Committee of the Legislature having jurisdiction over veterans' affairs may report out legislation to any regular or special session of the Legislature based on the information received at the meeting.

In essence, Madame President, women and men of the Senate, the Legislature, when we pass this bill, will be expressing our necessary oversight. The Attorney General, Aaron Frye, of the State of Maine wrote to our committee and said, clearly, 'The Legislature may exercise oversight over the operations of the MVH, including imposing constraints on its closure of facilities since the Veterans' Homes and the MVH Board are governmental entities created by the Legislature.' The most important part of the bill. Madame President, we know money cannot solve the problem alone, there is a stakeholder group that will be convened to come up with a permanent plan to make sure that we commit and keep committing to our moral obligation to serve our veterans when they need us the most. I will close briefly simply by saying that when we lead from the front and to the wind and to the tide or through the fire, we can achieve great things. With our votes today, by enacting this important piece of emergency legislation, we will achieve a great thing. We will keep veterans in their homes. It's something that we must do. I thank President Jackson for bringing this bill forward. I thank the Governor and her staff are helping the committee work out this language that will strengthen the public/private partnership between the Maine Veterans' Homes and the State of Maine and I look forward to green lights on the board shortly. Thank you, Madame President.

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON**: Thank you, Madame President. Ladies and gentlemen of the Senate, February 16<sup>th</sup> was the day that I was notified by a person in Caribou that the Homes in Caribou and Machias were scheduled to be closed. It was the first time that I had been made aware of this closure that had been voted on in October. Now it's no secret that we have tried to play catchup with nursing homes for a long time and so I was not as shocked that this nursing home, or these nursing homes, would be in trouble but certainly to be voted on some four or five months earlier for closure and not have been made aware of that was a surprise, was a shock. February 16<sup>th</sup>. Today is March 30 or 31.

Six weeks and here we are, today, and what I hope is going to be unanimous roll call to do what we can to keep these facilities open, to buy us time to make sure that we can do more for the future of all of them. It's not my intent to come down here and speak about it for my own personal benefit but those six weeks since I've been made aware of have seen like six months or more for the amount of people that have reached out to me and asked me to do whatever I could and ask others in this Chamber to do whatever they could and we're talking about people that live in these facilities. People that it's their home. To have them be told that they're going to lose their home and, on top of that, people that work there and work there, you know, tirelessly through this pandemic and have wanted to stay. I mean, we don't often have testimony where employees are talking against their employers in a public setting like this, but in this one we had many employees talking about how they enjoyed working at the Home, how much they appreciated it, how much they have had the sense of family working there, and the idea that you couldn't find people to work there, that had been brought to us, did not seem like the employees had that same feeling. They talked about there not being a shortage of staffing that had been portrayed and that these places were in trouble because of staffing issues. What I think is, you know, really important, why I wanted to come down and talk about this, is because as much as we're trying to help here today, and I want to take the time to thank the Veterans and Legal Affairs Committee, Senator Hickman, Senator Miramant, Senator Farrin did the hard work of coming up with a proposal that we have before us today, and then the unusual step that we took yesterday of asking the Appropriations Table, with Senator Breen, Senator Bailey, and Senator Davis, to move this today, and the Governor's, Chief Executive's work on this to put into the supplemental budget, give the Appropriations Committee the assurance that, you know, the money would be there, that we could do this, just another way to wrap this up. I think why it's important is because, still today, after all this great support, after unanimous report out of committee, I have people that continually talk about there's no amount of money that we can give to these homes to fix them, to keep them open. I have constituents that have been calling, telling me that they've been told they have to move their parents, move their parents to a facility three or more hours away from. That gives me a lot of concern. The Legislature is trying to do something to keep the commitment that we made to veterans' homes across the state, and let me tell you, early on, you know, in the process my bill was told to be a government takeover. That I was posturing in an election year. That, you know, there was nothing that I could do to stop these, even though later I was told that we probably could save Caribou but we couldn't save Machias. Now, I don't represent Machias but I do know what it's like in rural Maine and I had no intention of cutting a deal to save my area so somebody else would have to have the same problem. If nursing homes across this state are in jeopardy, and the Veterans' Home are, then we need to fix them all or try to do what we can to fix them all, and so why I think it is so important today is to make sure that the intent is very clear for what may come after this because we're doing what we can. The committees have done what they can and today, hopefully, the Legislature will finish the job and what they can to make sure that we're buying time to make sure that we can do more to keep these facilities open in the future and continue that commitment. I actually found out that I have a constituent in Perham who is a WWII veteran, a woman. Not that I didn't know there were women in the war, but she's a WWII veteran in my district and

she's trying to get into that facility and she's being told no. Now that, to me, is really quite unbelievable, that we would have a WWII veteran that would like to stay in a home for veterans and can't get into that because, for some reason, there's been a determination that these two facilities, out of six that are losing money, these two have to close. So, Senator Hickman read the Attorney General's opinion on why we have jurisdiction and why I wanted to get down is because I want to make it clear that I am very hopeful for the people that have run these facilities, and run them well, run them very well, that they continue to keep facilities open and continue to do what the Legislature is asking you to do here today. Make the commitment to the veterans that we've made for so long and keep that commitment and let's not get caught up in the politics of this, or the anger of being told that the Legislature does have jurisdiction. We're doing what we can. We're giving the resources that we need to right now and I want to thank, once again, the committees, the Legislature, the Governor, the Chief Executive for doing this because it is important. I don't think it's posturing. It's making sure that people that live in a Home feel good about it and can continue to do that and that anxiety and that fear of being moved three or four hours away. How do you make it? I know what that drive is like. How do you see our family in a way that is decent if it's that far away? So, hopefully today what we do makes people step up and continue the great service, but I want to make sure that it's said very clearly on the record, because I'm afraid that there may be something more coming down the line on this.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Somerset, Senator Farrin.

Senator FARRIN: Thank you, Madame President. First of all, I'd like to say thank you to President Jackson because I think I might be one of only two members in here that may be having a place in one of those Homes someday down the road. So, I appreciate that piece of it. The work that Senator Hickman and we talked about in the VLA Committee. But there's a couple of things I just would like to throw out there. This was not an easy decision by the Board of Directors. They're, all ten members are veterans and they agonized over this because one of the things that did come out at first, and the committee worked hard through this. was it about the money. That was the discussion. Then we got past that and I think, you know, the committee talked a lot about the level of care. We heard about the gold standard that our Maine Veterans' Homes provide for us and you heard me now, I guess in the last two or three weeks, talk about my buddy Nunzio that passed away. I went through this scenario with him and what amazes me, as a 30 year veteran myself and to be involved in the VFW and the American Legion and all these, is how many people don't realize what is a benefit and what is not and how people assume that the Maine Veterans' Home is, you know, controlled by the State of Maine and by Togus and by all these other things and it's not true. That's why we've had to work through this so hard and why it was difficult. To my colleague from Aroostook comment, we do have to keep our eye on the prize because, for those of you who have been here in the past, we have talked about this funding issue. We have talked about workforce issue. It took this coming to a head for us to have everybody come together to do this. One of the key points that we have in this bill, besides the staying open, and I had the same concerns that President Jackson has as well, is this stakeholder group because there are other states that find a way around this. Maine is one of

the only ones that funds the way that we do. So, we have an opportunity with the stakeholder group and those of us, you, that come back in the 131<sup>st</sup> to keep your eye on the prize. Keep your eye on the prize that is our Maine veterans and what we want to give them going forward. Don't let it stop today. Work with the Board of Directors, work with the Maine Bureau of Veterans' Services, work with the Administration, work with our Congressional Delegation. It's not one thing that's going to solve this. It's everybody together, Madame President. So, with that being said, you'll see my light green and I hope everybody else is as well as we send a message about how much we value the veterans in the state of Maine. Thank you.

# **JOINT RESOLUTION RECOGNIZING APRIL 2022 AS CHILD ABUSE AND NEGLECT PREVENTION MONTH**

WHEREAS, child abuse and neglect is a community problem, and finding solutions depends on recognizing that the effects of child abuse and neglect are felt by whole communities and need to be addressed by the entire community: and

WHEREAS, effective child abuse and neglect prevention programs succeed because of partnerships created among social service agencies, schools, religious organizations, businesses and law enforcement agencies; and

Please join me in supporting this bill so that we can ensure the protection of those in serious danger. Thank you, Mr. President, and ladies and gentlemen of the Senate.
