RESOLVE, to express objections from the Joint Board of Selectmen for Mapleton, Castle Hill and Chapman regarding the Governor's proposed biennial budget.

WHEREAS, the State Administration has submitted a proposed budget for the coming biennium that will dramatically shift the burden of funding state government to municipalities and property tax payers by eliminating or significantly altering several property tax relief programs; and

WHEREAS, the Governor's purpose for the proposed budget is to encourage local governments to save money by consolidating services and finding alternatives to funding municipal government; and

WHEREAS, the proposal to suspend municipal revenue sharing, redirect commercial vehicle excise tax and modify the homestead and business equipment tax reimbursement programs would result in an annual loss of approximately \$173,000 in revenues and represents an additional \$1.20 on the tax rate for the towns; and

WHEREAS, the homestead exemption property tax benefit loss will impact the individual property tax payer the equivalent of an additional \$1.30 on the tax rate; and

WHEREAS, the Towns of Mapleton, Castle Hill and Chapman have saved money through consolidation of services, reducing the tax burden on property owners by nearly 50% compared to similar Maine towns, and have led the State in finding alternatives by consolidating their municipal government through their 1992 Interlocal Agreement, operating joint administrative, highway, fire and law enforcement services;

NOW, THEREFORE, BE IT RESOLVED BY THE MAPLETON, CASTLE HILL AND CHAPMAN JOINT BOARD OF SELECTMEN that the Towns hereby declare their opposition to the Governor's proposed biennial budget and its detrimental shift of state government costs onto municipalities and property tax payers in the interest of forcing local governments to save money by consolidating services and finding alternatives to funding municipal government; and

BE IT FINALLY RESOLVED that the Joint Board of Selectmen calls upon the State Legislature to implement fair and equitable budget solutions that do not burden, but rather reward property taxpayers whose municipal government found alternatives that save money through consolidation of services.

TOWN OF FALMOUTH RESOLUTION IN OPPOSITION TO LD 300

WHEREAS, the property taxpayers of Falmouth are obligated to fund education for their K-12 students under the laws of the State of Maine; and

WHEREAS, more than 70 percent of Falmouth property taxes are spent to support education in the Falmouth School District; and

WHEREAS, the largest line item expense after salaries in the school district's budget is for the cost of health care insurance for teachers, administrators and support staff; and

WHEREAS, competition most often produces lower prices for goods and services and improves understanding of the value of such goods and services; and

WHEREAS, the 125th Maine Legislature passed LD 1326 An Act To Allow School Administrative Units To Seek Less Expensive Health Insurance Alternatives and the bill was signed into law by the governor to enable the release of health insurance loss data to individual school districts for the purpose of understanding and soliciting competitive proposals for health insurance; and

WHEREAS, the new law, having been in effect for less than one year, breaks a decades-long virtual monopoly by the Maine Education Association Benefits Trust over local health insurance costs by concealing the loss data for individual school districts; and

WHEREAS, the United States Federal Court in Maine and the United States Federal Court of Appeals in Boston both have rejected arguments by the Maine Education Association Benefits Trust that attempted to block implementation of this insurance reform

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FALMOUTH, that the Town Council hereby urges the 126th Legislature to reject LD 300, or any other legislation that restricts access to local loss data and designates the Town Manager to communicate the Town Council's opposition to this bill's sponsors, other legislators, the Joint Standing Committee on Insurance and Financial Services and other municipal officials.

JOINT RESOLUTION MEMORIALIZING THE UNITED STATES CONGRESS TO PASS A CONSTITUTIONAL AMENDMENT TO REVERSE THE RULING OF THE UNITED STATES SUPREME COURT IN CITIZENS UNITED V. FEDERAL ELECTION COMMISSION

WE, your Memorialists, the Members of the One Hundred and Twenty-sixth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the United States Congress as follows:

WHEREAS, United States Supreme Court rulings, beginning with Buckley v. Valeo and continuing through Citizens United v. Federal Election Commission and others, disproportionately elevate the role of wealthy special interests in elections and diminish the voices and influence of ordinary Americans; and

WHEREAS, Maine citizens wish to develop effective tools for self-governance, including strong laws governing elections and campaign finance; and

WHEREAS, the current legal landscape severely constrains the range of options available to citizens, frustrating efforts to reduce the influence of moneyed interest in elections and in government; now, therefore, be it

RESOLVED: That We, your Memorialists, hereby declare our support for an amendment to the United States Constitution regarding campaign finance that would reaffirm the power of citizens through their government to regulate the raising and spending of money in elections; and be it further

RESOLVED: That We, your Memorialists, call upon each Member of the Maine Congressional Delegation to actively support and promote in Congress an amendment to the United States Constitution on campaign finance; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the President of the United States Senate, to the Speaker of the United States House of Representatives and to each Member of the Maine Congressional Delegation.

READ.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Woodbury.

Senator **WOODBURY**: Thank you Mr. President. Senate colleagues, this Resolution calls for a Constitutional Amendment to overturn the Supreme Court's Citizens United decision and to allow the public, through their government, to more aggressively

regulate campaign finances and campaign spending. The Citizens United decision has been enormously destructive to electoral politics specifically, but even more broadly to the effective practice of democracy in America, by allowing essentially unlimited spending on elections by corporations, interest groups, and the very wealthy. Citizens United has, by comparison, marginalized the voice and influence of regular voters. We've seen the impact in recent elections in Maine as out-of-state money has flooded into the state and its total spending, supporting, and opposing candidates has grown expediential. We've seen campaigns in Maine inundated with distortionary advertising, robotic phone calls, push polls, attack ads, and substance less mass mailings so that the genuine views. character, experience, record, and vision of candidates are overshadowed and obscured. This is not reasoned debate of the issues. This is not respectful differences of opinion. This is not informed and thoughtful advocacy. It's not good democracy. It's something much closer to buying influence over government. That's why we've seen so many thoughtful national leaders from across the political spectrum lamenting the Citizens United decision, some of whom are quoted in the handouts that are on your desks. That's why there is a growing movement, nationally, calling for a Constitutional Amendment to overturn the Citizens United decision. Many municipalities have passed Resolutions calling for this action, including 27 in Maine so far. Twelve states have passed Resolutions. If we pass this Resolution today Maine can become the thirteenth. I'm excited and proud to be introducing this Resolution for Maine and to be joining in this historic movement around the country. Thank you, Mr. President.

Senator **GRATWICK**: Thank you Mr. President. I rise to support this particular request for an amendment to the United States Constitution for Citizens United. One of my favorite quotes is from Winston Churchill who said that Democracy is really the worst form of all governments except for all the others. I think that the Citizens United decision really displays where we've got the worst kind of government. I think it does not serve us well. I think this process whereby we can change our government ourselves peacefully and appropriately and incrementally really illustrates the very best. I support this wholeheartedly. Thank you, Mr. President.

JOINT RESOLUTION TO SUPPORT COMPREHENSIVE IMMIGRATION REFORM

WHEREAS, Maine's identity is defined by its promise of equality, esteem for diversity and commitment to innovation; and

Senator **CUSHING**: Thank you Mr. President. Ladies and gentlemen of the Senate, I rise today to speak in regards to the pending question before us. I feel it is unfortunate that we did not reach a conclusion that would once again allow individuals in our state another pathway to support themselves through a different form of employment than they may ultimately seek, but at least an opportunity for them to once again start to generate household

income from active employment and put themselves in a position to really present their best features and skills in a workplace environment. I think many of us know that Maine has a tremendous number of small business people, many of which, because of the enormous burdens that we place on our business community, have found that a pathway to find good quality people is to use temporary employment agencies. In the event that this Body seeks not to accept the pending question, I would ask you to consider the opportunity to support this bill from the Minority position and give these working people a chance to get back into the workforce. I thank you for your time and consideration.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator PATRICK: Thank you Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, Maine's unemployment insurance law already imposes similar requirements that workers must meet in order to receive unemployment benefits that they have earned. They must register for work, search for work, and accept any offer of suitable employment made to them. If they do not, they will be disqualified from receiving benefits. L.D. 1033 proposes an additional eligibility requirement that workers must meet in order to receive unemployment benefits. It would require them to register for work with a temporary staffing agency in order to be eligible for the benefits in any week after they have registered for 13 weeks of benefits. As I just mentioned, unemployed workers are already required to register for work with their local Career Centers. The purpose of our statewide network of Career Centers is to assist people in finding work, taking into account their skills, abilities, and employment history and other qualifications. Yet under L.D. 1033 these workers would lose their unemployment benefits if they did not also register for work with the nearest temporary staffing agency. In addition, L.D. 1033 does not include a good cause provision, allowing for a waiver of this new requirement in areas where there are no temporary staffing agencies. We believe that the intended protection would be difficult to enforce with any reasonable degree of equity. For example, simply because a person may live in reasonable proximity to a temporary employment agency that does not mean that particular agency has a job that meets the worker's skills, ability, and qualifications. We have serious concerns that the new eligibility conditions imposed in L.D. 1033 would exacerbate the already unacceptable benefit delays faced by thousands of unemployment claimants here in Maine. Administration of the requirement proposed in L.D. 1033 would generate increased numbers of non-monetary determinations that would be required each week. The department estimates that approximately 800 to 1,000 claimants would be affected by this new requirement weekly. If there is any question as to whether or not the requirement has been met the case would be scheduled for fact finding, would be added to the queue with the many hundreds of other cases waiting for a decision. I think there are enough hurdles for a person to go through in order to receive unemployment benefits. Recently this spring I actually went to the Maine State Chamber of Commerce's Leadership Conference and ask the question to them. They were asking us questions. It was really a neat thing. I wanted to turn it around to them. I asked each and every business person, "Answer me one simple question. What is your greatest asset in your company?" That is one of the cases where you should know the answer. That was;

our employees. The unemployment system is such that nobody wants to get unemployed. We have a system that works great. although some say there is an awful lot of fraud and everything under the sun. Our system works good. The unemployment system is there for the need for someone who loses their job. The expectations are already there. There are certain levels that one must have to rise to in order to get it. If he doesn't he gets disqualified. It's just unbelievably hard for me to understand how we are going to continually go after our greatest assets, our workers, in their time of need. I really don't believe we have to have any other hurdles and I want to make sure that Maine's issue with unemployment and the ability for them to handle their cases and get them turned over in a decent amount of time gets better. All this is going to do is make it harder, ladies and gentlemen. I would ask you to support the Ought Not to Pass motion. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Cleveland.

Senator CLEVELAND: Thank you Mr. President. Ladies and gentlemen of the Senate, my good colleague, Senator Patrick from Oxford, has explained very clearly what the current rules and requirements are, which makes it clear that unemployed individuals must seek and take appropriate and suitable work. During the hearing we received comments from a number of various individuals, including the temporary staffing agencies who would be required under this bill to take these individuals in and sign them up with their agencies. I wanted to share with you one of the testimonies we received from a staffing agency, Maine Staffing. This is their testimony. "However, it would be both an administrative burden and costly if all unemployed workers were required after 13 weeks to register for employment with staffing companies. The process of interviewing and screening alone would impose significant costs." Staffing companies also would incur additional costs in tracking these workers, contacting them and contacting the Maine Department of Labor. It is estimated that this would affect approximately 800 to 1,000 unemployed individuals a week, which is a significant number and a significant burden that would be put on these staffing agencies. Though this may be a well-intended bill, I share with you that even the agencies that have been asked, the private agencies that would have to take on this burden, see it as unworkable and costly and ineffective. For that reason as well, we should vote Ought Not to Pass.

THE PRESIDENT: The pending question before the Senate is the motion by the Senator from Oxford, Senator Patrick to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?
