WHEREAS, the Legislature has learned with deep regret of the death of:

Bruce Roy, of Jay, prominent labor leader and member of his community. Mr. Roy was a 1975 graduate of Jay High School and worked at the James River Otis Mill in Jay, presently Wassau Paper Company, for more than 29 years. He was a member of PACE International Union, now known as the United Steel Workers, Local 11 of Jay, and served as treasurer/recording secretary and president of the Maine Labor Council of the United Steel Workers and secretary/treasurer of Maine AFL-CIO. He spent much of his time lobbying for laws to aid and protect working families and worked tirelessly to promote the election of politicians who support working families. Mr. Roy was a charter member and officer of the Western Maine Labor Council and a member of the United Steel Workers Contract Action Team. In August 2008, he was appointed as the emergency response team coordinator for United Steel Workers District 4 in support of families affected by a workplace fatality or a critical injury and was recently honored for his activism and advocacy for the United Steel Workers members and families. Mr. Roy was recently appointed and confirmed to the Maine Workers' Compensation Board. In addition to his work and labor activities, Mr. Roy served the Town of Jay as a selectman, assessor and overseer of the poor, was a member of the board of directors for Franklin County Community Action and was serving as a member of the board of assessment review for the Town of Jay and the Tri-Town Ministerial Fuel Fund of Livermore Falls. We acknowledge Mr. Roy's exemplary and dedicated service to his profession, the labor movement, his community and the State. ## READ.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bryant.

Senator BRYANT: Thank you, Madame President. Ladies and gentlemen of the Senate, it's with a heavy heart and some sad emotions today that I rise to speak to the legislature on the record in memory of one of Maine's fallen soldiers in the labor movement and a great family man. I had prepared a couple of pages, but I think what I'll try to do, and it may be a little bit dangerous, is go from my experiences over the last 30 years. At some point I think we have to recognize how old we really are. I may not feel like we've been in the labor struggle for 30 years, but we have. It brings me back to 1986 in the Rumford mill where we were on strike. The atmosphere over the next two or three years was that corporations had the upper hand and, in fact, they could scab out any mill they wanted to. Who was going to stand up and slow that freight train down? What we had here with Brother Roy was one who was willing to stand up. He was willing to, even though he knew that the fight would probably be lost at the end of the game, because someone had to stand up and fight the fight to slow the train down, and he did that.

As we moved forward into the 1990s, we had issues with Workers' Compensation and this Body hurt workers severely. Brother Roy worked tirelessly over his whole career to try to mend some of the fences. I think it was easier for people to ignore as long as they didn't see the pain and as long as they didn't have to deal with the person that couldn't provide for their family. As long as they didn't have to see that and didn't have to go there and help the person pay their mortgage or give their kid \$20 so they could go to the show. As long as they didn't have to see that, everything was good. Bruce was one of those who continued to work that issue, as he did on a number of labor issues. I remember many times meeting with him on strategic planning around the whole state of Maine. He worked tirelessly.

That brings us up to the present. He's done a number of things. Where to start is the problem with Bruce. He's done so much and put his whole life on the line for his community, for his co-workers, and for the workers of the state of Maine. The last go around was with Wausau Paper. We had a situation where they couldn't make a profit from that mill. They could make more money if they shut it down, moved the equipment out, and dried up the marketplace. Bruce made a tremendous effort to stop that machinery from moving out of Wausau Paper. That needs to continue, that struggle. We will continue that fight for him, and we will continue to try to make this state a better place.

He had an opportunity to be on the Workers' Compensation Board. He felt strongly that the workers in the state of Maine got a raw deal and that they are suffering under the current Workers' Comp policies. He had an opportunity to try and make a difference there. It saddens me that he didn't get that opportunity. I remember April 7<sup>th</sup> clearly. I have to apologize to his family because he got some phone calls that day from me and other labor people who were concerned about the meeting we had with the Governor. We were waiting on the second floor, under the stairs, to talk with the Governor about making sure that the machinery in Wausau Paper stayed in that mill. Brother Roy had part of the plan that we wanted to implement with the Governor, and he wasn't there. He didn't show up. Sometimes within the labor movement we have our own language and probably some of the phone messages that were left when we were trying to locate him were inappropriate for that day. He never showed up for that meeting and he never showed up for his first Workers' Compensation Board meeting.

It's with great gratitude that I have an opportunity to show my respect for Brother Roy. I'm hoping that his wife, Nancy, and his daughters, Jessica and Joanne, and their extended family know that somehow this proceeding gives them a small opportunity to, along with me, move forward in this painful situation. Thank you, Madame President.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON**: Thank you, Madame President. Ladies and gentlemen of the Senate, I certainly don't want to get up and try to follow the good Senator from Oxford, Senator Bryant's very good expression of sentiment for Mr. Roy because the Senator from Oxford, Senator Bryant, knew him much better than I did. My interaction with Bruce was very short and I only had the opportunity to meet with him a couple of times. He seemed like a very good man who had a great heart for people. I've noticed that many times when people do things right, they aren't always the most popular. Bruce certainly knew what was right and wasn't afraid to stand up for those things. I just want to take the time to tell his family how unfortunate it is and how sorry I am for their loss. It certainly is a sad day when we lose someone, especially someone of great caliber like Bruce. My heart is certainly with you.

I would like to read part of the amendment to this bill. It starts in with a whole series of steps you must jump through to even grow industrial hemp. They did this in British Columbia or Alberta. At one time they had 42,000 acres of industrial hemp. That's down to 8,000 acres. There is no market for it. I'd like to read from Committee Amendment "A" (H-356). They have a definition for this stuff, 'as used in this chapter, unless the context otherwise indicates, industrial hemp means any variety of Cannabis sativa L. with a delta-9-tetrahydrocannabinol concentration that does not exceed 0.3%.'

President **MITCHELL**: The Chair would advise the Senator to address the Committee Report and not the Amendment. We have to accept the Report and then you may speak on the Amendment.

Senator SMITH: Thank you, Madame President. Men and women of the Senate, I just wanted to say a couple of words about this bill and the idea that it brings forward. This is a bill that I sponsored. It basically calls for a Science Advisory Board to be available for legislative use. It is designed, at least as I see it, as a non-cost item to the Legislature and would function like many other advisory boards and commissions do for the Legislature. I note in today's calendar, item 5-10 that we established a Probate and Trust Law Advisory Commission. My view of it is that this Legislature is very efficient, and it moves legislation very fast. Several of the committees deal with issues of some importance in the science field. As time goes by and the world becomes more technical and more science-oriented, we are going to have important questions concerning science that we will want to get quick and ready answers to from a source that is not from the lobby, but from a secondary source that is not attached to a part of State government that may be under a political agenda or directive to answer questions. It would be a neutral source that the Legislature can turn to. It's obvious today that this bill is not going to go forward, but I think it's an idea that needs to be thought about by the members of the Legislature going forward. I think it's an idea that needs to be developed further, and today I would simply ask that when the votes are taken, that they be taken by yeas and nays. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Hastings.

Senator **HASTINGS**: Thank you, Madame President. Ladies and gentlemen of the Senate, I just want to echo what the Senator from Piscataquis, Senator Smith, has just indicated. I know the Judiciary Committee puts great reliance on the advisory opinions given to us from CLAC and FLAC, the Criminal Law Advisory Committee and the Family Law Advisory Committee. Both of these committees are made up of experts in their respective fields from all perspectives. They have no vested interest in the outcome of the bill. They give us very timely advice as to the implications of each bill. I would suspect in the area of science

and scientific questions that such advice would be at least as equally welcomed by the Committee. Thank you.

The issue isn't really whether or not we need more scientific information, it's whether or not we're going to task this group of volunteers with more work than they already have in order to work on the innovation economy. Because that's more than I think we can expect from volunteers, I would hope that you all support the Majority of the Committee. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Davis.

Senator DAVIS: Thank you, Madame President. Men and women of the Senate. I urge you to support the Minority Report of L.D. 921, An Act to Eliminate Maine Clean Election Act Funding for Gubernatorial Candidates. This bill would limit public funding out of the Maine Clean Election Act to legislative candidates. Pat LaMarche, Barbara Merrill, and Chandler Woodcock fought hard to become Governor in the 2006 General Election. They are all fine human beings who disagreed on issues. None became Governor but Maine taxpayers subsidized these three candidates whose ideas they disagreed with. They were given enormous sums of money from the Maine Clean Election Fund. Over \$3.5 million in public funds were dispersed to gubernatorial candidates in 2006. These costs will continue to escalate as more and more individuals are attracted to the easy money, the fame, and the recognition that comes from running for the office of Governor. Limiting public funding to candidates will save the State of Maine millions of dollars. Already six candidates have announced their intention to run for Governor in 2010, with three of them declaring their intent to qualify for the public funding. This money would be much better used to give assistance to Maine's most vulnerable citizens and reform Maine's health care system. Additionally, it might go toward increasing or putting back the longevity pay for State workers. Maine has a financial crisis, as does the rest of the country. In this troubled economy, can we really justify giving millions of our taxpayers' dollars to anyone who can gather 3,250 \$5 checks to achieve their moment in the limelight? We, the people of Maine, are being taxed to subsidize ideas that we disagree with.

I leave you with this last thought. Will we ever again, under the Clean Election Act, elect a Governor with a majority of the vote or will the gubernatorial vote continue to be sliced into smaller and smaller portions, as was the case with the 2006 General Election? There were five candidates, two that were privately financed and three that were publicly financed, with the winner receiving 39.5% of the vote. I thank you for your time and I urge you to vote for the Minority Report. Thank you.

Senator **SULLIVAN** of York moved to **INDEFINITELY POSTPONE** the Bill and accompanying papers.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN**: Thank you, Madame President. Men and women of the Senate, this item has been addressed in the Budget that was passed yesterday as to amounts and qualifying candidates. Therefore it is not needed and it would not be in agreement with the budget. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN**: Thank you, Madame President. Men and women of the Senate, I would urge you to oppose the pending motion. I'm going to read from the <u>Report on Qualifications for</u> <u>Maine Clean Election Act Gubernatorial Candidates</u>. The projected payments to gubernatorial candidates in 2010 projects that we will need \$6.6 million in order to fund the candidates who will most likely qualify for the Fund, \$6.6 million. Yes, this was passed because the people were presented with a referendum, but I don't think they ever dreamed that we would put forth a total of \$10 million in 2010 to run candidates for the Legislature and

Governor. Legislative candidates use this in excess of 85% of the time. If you translate that to the number of people who are interested in running for Governor, and who can qualify for the Fund, the total will be over \$10 million that you will have to factor in to the budget which we discussed yesterday. The very budget in which we talked about the pain that every constituent will feel, the cliff that we are quickly approaching, and the lack of federal stimulus money in order to balance the budget. Yet we're going to be asking the taxpayers of the state of Maine to agree that we should be spending \$6.6 million to try to put forth one credible candidate who can win the election.

Public funding does not necessarily equate with credibility. I don't believe that I want to go back to my taxpayers when the budget comes up in 2010 and say to them we cut funding for the mentally retarded, we cut funding for the homeless, we issued ten furlough days per year in the next budget to State employees, and we are cutting the services for the neediest so that someone can buy advertising, cardboard pieces of paper that will end up in the dump and landfill, stickers, and buttons. I think if you put the question to the people today, 'Would you rather we spent that on services or would you rather we spent that on candidates running for Governor?' common sense would prevail. Yes, we passed a budget yesterday. Yes, we dealt with a very small part of this question. However, we are looking at the same or worse situations when we talk about the next budget and I don't believe that today we should spend \$6.6 million on a Gubernatorial election when we can't even tell what we're going to have to cut in 2010. This is an easy cut. It should be one of the easiest cuts you make. I would urge you to vote against the pending motion and pick up on a little bit of common sense and a little bit of what the people really might want. While they support Clean Elections, they also support what we're actually supposed to do with their taxpayer money. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator **DIAMOND**: Thank you, Madame President. Men and women of the Senate, first let me say that I've been a strong supporter of the Senator from Cumberland, Senator Davis, and this bill from day one of this session because I thought, as the Senator from Penobscot, Senator Plowman, has indicated, the money could be used elsewhere much more appropriately. I would say to you the budget that we just passed does have a \$2 million cut in the Gubernatorial Clean Elections piece. It also cuts across the board on all Clean Elections another 5%. At least our thinking on the Committee, and I think leadership on both sides joined us with this. I believe, I maybe jumping on that one a little bit. As a result of that, we felt the 5% across the board and the \$2 million cut, along with the increased threshold by the Committee of Jurisdiction, was the appropriate way to address the issue. I personally commend the Senator from Cumberland, Senator Davis, for putting this bill in, because I think it's a point that needed to be made, and I think he made it well. Thank you, Madame President.

**THE PRESIDENT**: The Chair recognizes the Senator from Washington, Senator Raye.

Senator **RAYE**: Thank you, Madame President. Men and women of the Senate, I rise briefly to say that this member of leadership did support the budget. It was one of those things we

negotiated and accepted as part of the budget. However, I do support the Senator from Cumberland, Senator Davis, on this in terms of what I would have really preferred to see in the budget. I just wanted to state that for the record.

On motion by Senator **RAYE** of Washington, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Sullivan.

Senator SULLIVAN: Thank you, Madame President. Men and women of the Senate, I also support the Senator from Cumberland, Senator Davis' comments. I happen to not use Clean Elections, as I am a traditionally funded candidate. I don't disagree with the Senator from Penobscot, Senator Plowman's statement that if the people were to vote today, would they support this Clean Elections. I think she might be right in that they might not support it, but the fact is the Committee of Jurisdiction worked with what is now still a citizens' initiative, funding to Clean Elections, and that's what they want. We also worked within the idea that the budget was going to make another 5% cut across the board, and we raised the qualifying candidates for the Governor's race to a larger amount so that the seed money for the primary would be collected ahead of time and sort of self fund that piece. In that framework, the Committee worked with what the people of Maine had voted for. I support the motion because we worked within the law that exists now. All of the statements that have been made are very true. However, we've taken care of what we could in that framework, and I think we need to honor that piece and vote against it. I look forward to seeing in some way, shape or manner, a bill like this in another session, or perhaps another citizens' initiative. I don't disregard that but here we are, here are the facts, and here is the law that we must work with. We must respect the people for that vote at this point in time. Thank you, very much.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator SCHNEIDER: Thank you, Madame President. Men and women of the Senate, I'm amazed at this discussion today against the Clean Election system. This has made a tremendous difference in this state as to the ability to run. I am a Clean Election candidate. I can tell you that as I go door to door and speak with constituents, they really believe in this system of Clean Elections, and getting money out of politics as much as possible. It is a little disheartening to me to have my colleagues speak in opposition when so much of this Body, as well as the other Body, utilizes this system to run their campaigns. I hope that we would give a little bit more credibility to this system which has advantaged the ability of people to run who might not have otherwise been able to have the ability to take on an election. I am in favor of this Indefinite Postponement because I think that we should be supporting this initiative brought by the people. This is something that's actually positive. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Sagadahoc, Senator Goodall.

Senator GOODALL: Thank you, Madame President. Men and women of the Senate. I rise today in support of the good Senator from York County, Senator Sullivan, and her motion to Indefinitely Postpone this bill. The work that the Policy Committee did was comprehensive, was holistic, and it took in the big picture. We focused on how to entice more people to run privately. We increased the thresholds with a bill in today's calendar. We increased the ease with which someone can collect contributions, similar to what's going on in the federal system, where you can collect your General and your Primary contributions prior to the Primary election. In addition to that, last session the threshold was increased to 3,250 \$5 contributions. This year, in a bill you will see shortly, we will have seed money requirements for Gubernatorial elections of \$40,000 in \$100 increments, so the bar is set much higher. At the same time we had buy-in from many parties. I won't say it was unanimous, as I don't have the reports in front of me today. However, I think people recognize that these are very challenging financial times. The Appropriations Committee worked very hard on a compromise, and this was the will of the citizens in an initiative that passed overwhelmingly. I encourage you all to support the pending motion.

**THE PRESIDENT**: The pending question before the Senate is the motion by the Senator from York, Senator Sullivan to Indefinitely Postpone. A Roll Call has been ordered. Is the Senate ready for the question?

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bryant.

Senator BRYANT: Thank you, Madame President. Men and women of the Senate, I rise today in opposition to the pending motion. This has been an issue for the last three or four years that the Committee has tried to deal with without much results because it's always easy for us to basically pick on the kids. It's easy to restrict them from activities that we feel, as a Legislature or as adults, they may not be ready for. I would suggest to this Body that it's the parent's responsibility and it's the parent's guidance and it's the parent's ability to allow their kids to operate recreational vehicles within their scope. It also takes away a tool. When we talk about kids and we talk about weight problems we hear about a lot of bills that come out concerning why the kids can't get outside or why can't we have kids do more activities. Most of the activities we, in our great wisdom, have restricted kids from having the opportunity to do and took the rights of the parents to use their judgment on whether they will allow their kids to operate. I oppose the pending motion.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator JACKSON: Thank you, Madame President. Ladies and gentlemen of the Senate, I stand with the Senator from Oxford, Senator Bryant, in opposition to this. I introduced this bill and also one in the 122<sup>nd</sup> Legislature. I think back in the 121<sup>st</sup> there had been a task force commissioned to address problems with ATV use. One of the recommendations that came from it was that if you were riding on other people's land you had to have written permission to be there. It's the only real activity requiring that. We don't require that with hunting. We don't require that for snowmobiling or anything like that. ATVing, I guess, has become somewhat more of a problem, so we went this extra step and required people to have written permission before they can actually be on the land. Along with that, one of the other major things that we did was require that kids under the age of 16 could not ride on other people's land or State approved trails without an adult, someone over 16. What that actually ended up doing, in my mind, was making a lot of kids not able to ride ATVs period. Many families, if they are lucky enough, have only one ATV. Obviously, if you don't have two you can't have an adult go along with them. I put this bill in. I understood that there was a

problem, but I think how it actually got solved was by the written permission requirement. We had some problems in northern Maine with ATVs but I don't think it rose to guite the same level as what southern Maine probably experienced. This is just my personal feeling, I don't think it was the 14 and 15 year olds who were causing the trouble. I could be wrong, but for the most part I think those kids, if they do make a mistake like that, if you tell them many times, if not all of the time, they will do right. I think the older kids, including myself, are probably the ones that, even if you tell them, sometimes they just don't get it through their head. The written permission part goes for everyone. That does solve, I think, the problem of people ruining other people's lands and things like that. This does nothing to affect that. What it would do, on trails that the State approves and they put money into to create and everyone has the ability to ride on those trails that are 16 years old and above and would not have to have written permission because they are State approved trails, this bill would allow children that were 14 to ride on those trails also. I think it's a good compromise. ATV Maine is behind it as long as kids have training and we'll talk about that if we can get by this motion. ATV Maine feels that if the kids are 16 years old, they don't want to take training at that point. They feel they need to have them when they are younger for it to really sink in. I've got to tell you, I get accused sometimes of using my children to make points and things like that, but for me it is something I know. It's an issue that I have first-hand experience with. I have one son that's going to graduate in a couple of months, he's almost 18. In the past he rode ATVs around the house but he couldn't go anywhere else, so he really has no interest in ATVing now. When he turned 16 he got his license and that's what he does now. He drives. My other son is 15 and he likes to go ATVing, but he can't go on the trails. It's funny, it just happened he called me. They are in Fort Kent right now celebrating. He just got his learner's permit, so he's able now to drive a car, and in a short while he'll be able to drive it by himself at 15, but at 16 he can't ride an ATV on State approved trails. There's something wrong with that. We will give people that are 15 years old the ability to get out in the public with oncoming traffic, legally, but we won't allow them to get on a State approved trail and ride an ATV. My son, or anyone's son, at 15 years old can now apply to get a permit to ride a motorcycle on the highways in Maine, but he can't ride that motorcycle on the ATV trails in Maine. I just find that incredible. I can't believe that this was actually what people were going after. I think the problem with ATVs was that people were on other people's land without permission, and we have a law now that is in place to correct that. If it gets enforced or not, I don't know, but I still feel that it's not the 14 year olds that are ruining everyone's land. I think for sure the older people are probably more often the problem. People would argue the safety aspect of it. We have all kinds of studies that show that the people who are getting hurt on ATVs are well into their late 30s and 40s, not so much the kids. Still if you want to protect children, give them training, which we would do, and show them how to ride safely. We're not getting that now because they have to wait until they are 16 to ride on the trails and by the time they are 16 they have probably lost interest in the whole sport. This is like one of those things where you stand in the middle of the road and you know you're going to get hit but you can't get out of it. This is kind of like what this bill is. I just can't believe that this is what we want for a policy in this state, so I ask you to vote against the Majority Report.

**THE PRESIDENT**: The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator TRAHAN: Thank you, Madame President. Ladies and gentlemen of the Senate, it is with great anxiety that I rise in opposition to the two previous speakers. I serve on the Committee with them and have great respect for both of them, but we disagree on this issue and I would like to rise and tell you why. It's not that I don't want youngsters to participate with their parents in such a wonderful outdoor activity as ATV riding, but I just don't believe that a 14 year old has the strength or the experience to run such a very powerful machine. A person at the age of 14, I don't believe, when it comes to a situation where they have to manhandle a machine of this weight and power can actually do that. That's just one reason why I oppose this change. Secondly, unaccompanied by an adult on an ATV with youngsters without barriers is a problem. I've met the previous speaker's son and I think he can handle a 4-wheeler. It's the ones of that age that can't handle the 4-wheeler that I have concerns about. I think their safety is at risk. I think that public safety is at risk. I think some kids can get into a lot of trouble on an ATV where they might not get into trouble off an ATV. I was on the Committee when this policy was implemented. They made the right decision and resolved a lot of the issues around ATVs. I hope that this Body will maintain that position and I, unfortunately, have to rise in opposition to the two previous speakers. Thank vou.

At the request of Senator **BLISS** of Cumberland, Reports **READ**.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator JACKSON: Thank you, Madame President. Ladies and gentlemen of the Senate, well sometimes great ideas aren't the most popular and, as the Senator from Lincoln, Senator Trahan has mentioned, there is always a safety factor with anything. We were just talking about this a while ago. When I was a kid I didn't have a cell phone. I left my mother hanging all the time and she never knew where I was. I think about that now and I think what a bad, bad young son I was. While I can't afford it, both of my children have cell phones because it scares me to death that I don't know what's going on with them. At the same time I can't wrap them up and not ever let them experience anything. The thing about it is that ATVs can be dangerous. If we want to take away some of that danger, the way to do it is to teach kids, give them training, and make them wear helmets. This would do that. If we don't ever let them ride, when they get to be 16 and they don't have to do any of that. They don't have to have training. They don't have to wear a helmet. How much safer are we actually making them? Another thing is that you can legally run a canoe and motor at 10. You can run a Skidoo at 12. My son has a Skidoo that goes way faster than I can take but it's really not considered a high powered Skidoo. It goes a lot faster than any ATV on the market. It's just the inconsistencies. I buy him a Corvette tomorrow and that is legal. Just for a regular ATV we're going to say, 'No, you can't have that, that's not safe enough.' I think that there are a lot of things that we allow people to do that aren't safe and we could pass something that mandated everyone to have life jackets on when they are on the water but we don't do that. That saves lives. For me it's just the inconsistencies. Yes, by the time this would pass my son would be 16 so it really

doesn't make a difference. I still don't see it's right for kids and I had to tell my kids, 'No, you can't do that because it's against the law.' Sometimes they follow it, sometimes they don't. It's just such an unfair thing to me and that's why I put the bill in.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bryant.

Senator BRYANT: Thank you, Madame President. Men and women of the Senate, just to bring two more points to the debate. The reason why the task force came into play is because there was abuse of ATVs, and we worked on that. We made it so you can't ride your ATV on anyone else's property and we made trails, and the clubs got together and made State trails where people can drive, but that's a separate question. The question that bothers me, and why I support this bill, is that myself, as a parent, that knows the ability of child and that child has the opportunity between probably the ages of 10, 11, 12, 13 and maybe 14 to participate in the activities of outdoors. Once that child gets 16 or 17 and playing basketball or whatever sport they play in year round, that child is lost to the activities that you can have them do. That is what my main point is in supporting the bill. It is the parent's right and the parent's responsibility to understand what the child is capable of. I will go on record right here, there are a lot of 14 year olds that can operate an ATV a lot better than anybody over 20, 30 and 40. When you look at the statistics of people getting hurt. When you look at the accident report that IF&W wardens bring in, it's not the 16 and 17 year olds getting hurt, it's the 34, 60 and 55, all in that range. We've just made this a blanket idea that if you're not 16 you can't operate an ATV. I just think that is wrong.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Nutting.

Senator **NUTTING**: Thank you, Madame President. Ladies and gentlemen of the Senate, first I pose a Parliamentary Inquiry.

THE PRESIDENT: The Senator my pose his inquiry.

Senator **NUTTING**: Thank you, Madame President. Is the motion before us now to accept the Majority Ought Not to Pass Report, or is it reconsideration of accepting the Majority Ought Not to Pass Report?

**THE PRESIDENT**: We reconsidered acceptance of the Majority Ought Not to Pass Report.

Senator **NUTTING**: Thank you, Madame President. Last week in my district we had a listening session put on by the Department of Agriculture, Conservation and Forestry on an exciting new proposal concerning the Androscoggin Riverlands proposed new State Park. People are very excited about that. They want it left very undeveloped but with multiple use. We had a great turnout for that listening session. The people who came to the session had one thing on their minds and that was ATVs and the damage that those ATVs, ridden by 16 year olds and older, had done to those State lands and how could we have a trail there that's just for ATVs. People want that, but they were very concerned about would there be enough ATV regulation on 2,200 acres in Turner. People didn't want any ATVs at all on the 400 acres in Leeds, on the other side of the river. After that discussion and some experiences on our farms, I think the ATV clubs have made a step in the right direction, but I think we still have issues, even with 16 year olds and older, handling ATVs. I'm very apprehensive of lowering that to 14 year olds, so I will be supporting the pending motion. Thank you very much.

**THE PRESIDENT**: The Chair recognizes the Senator from Franklin, Senator Gooley.

Senator **GOOLEY**: Thank you, Madame President. Ladies and gentlemen of the Senate, I wasn't going to get up on this issue, but I have two grandsons, ages six and four. They live in the Bangor area. Their other grandfather did buy the oldest one a little ATV. There are all kinds of sizes of ATVs. There are large ones, medium ones, and small ones. I happen to own a large one myself. I use it in my business. I watched these little kids operating around the house on their little ATVs, and it's a great learning experience. In rural Maine there's a different lifestyle, especially up in the Allagash. I've been up in Allagash, so I understand. I guess I am sensitive to the safety issues, and parents have to be responsible for educating their children, so I guess I empathize with reducing the age to 14. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator TRAHAN: Thank you, Madame President. Ladies and gentlemen of the Senate, I just would like to read the summary of this bill for you and maybe just stress again what we're getting ourselves into. 'This bill lowers the minimum age that a person may operate an ATV unaccompanied by an adult from 16 years of age to 14 years of age.' It's not just the safety issue that concerns me. It's also the camp owners. I have a personal friend who's a banker at Katahdin Trust whose camp was vandalized by youngsters who came in on a 4-wheeler. The mischief that youngsters can get into with a machine that can travel great distances is also an issue. Again, I stress to you how much this frightens me. If we go down this road we're going to return to the days when our committee room is full of people who are posting their property and who are bringing up environmental issues of kids running up and down brooks and tearing them to pieces. I caution you. I've been down this road before and it's not a very pleasant one.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON**: Thank you, Madame President. Ladies and gentlemen of the Senate, I would just say that this is only going to be on the State approved land trails. That would be illegal if you 14 or you were 44.

**THE PRESIDENT**: The pending question before the Senate is Acceptance of the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?
