REVEREND CRANE: Dr. Martin Luther King Jr. devoted his life to overcoming what he called the triple evils of poverty, racism, and militarism, those interrelated forms of violence that still exist in a rather vicious cycle in our society. As long as homelessness and hunger persists, as long as there are people unable to find employment, the evil of poverty will continue to stand as a barrier to living in the Beloved Community. "There is nothing new about poverty," wrote Dr. King, "but let us not be complacent about living with it." We have all at times been guilty of indifference to the poverty and deprivation in our midst. Let us hear again Dr. King's words about what it takes to be a great nation. "Ultimately, a great nation is a compassionate nation. No individual or nation can be great if it does not have a concern for the least of these." Let us rather reach for Dr. King's global vision of the Beloved Community in which all people can share in the wealth of the earth. In the Beloved Community poverty, hunger, joblessness, and homelessness will not be tolerated because international standards of human decency will not allow it. Martin Luther King Jr. believed the only way to create that Beloved Community was by people in local communities working together through a series of non-violent steps to reconcile differences, redeem inequities. and to practice the kind of love that seeks to preserve and create community. This objective, of course, is what you, as our elected legislators, are also seeking to achieve. All too often, though, the efforts to work together towards the Beloved Community unravel into finger pointing and blaming our opponents. We must practice the non-violence of Beloved Community in order to help bring it about.

Let us pray. God of great and God of small, You alone are worthy of our praise. We thank You for leading us this far by faith. Through hard times and changing times, we turn to You again and again, seeking Your light to shine on the way. Keep us mindful of those among us who have special needs, those with not enough income to make ends meet, and those who need employment or new job skills. Give us hearts of compassion to work together on the legislation that will help to bring about better days for all people. Keep us forever in the path, we pray, the path to becoming the Beloved Community where all may dwell secure, free from violence and fear, free from want and isolation. Give to Your faithful servants here in this Legislature grace sufficient for the challenges they face and power made perfect in their weakness for the sake of Your divine vision of a world held together by love with peace and justice for all creation. Amen.

Senator CLEVELAND: Thank you Mr. President. I wanted to share with the members of the Senate today that the work that we did on the Energy Bill has produced some great fruits for the state of Maine going forward. As you know, we're having an extremely cold winter. Right now electricity, on the stock market, is 30¢ a kilowatt hour and natural gas is up to more than \$70 a unit, above the basis differential which is pushing the price up. These are all of the issues we spoke to in the Energy Bill. The good news is that, because of the work we did here and with your support, we were able to provide the support to the Public Utilities Commission, the Chairman, to go forward and speak with the other New England states. Today they have announced that they have come to an agreement that all six New England states have agreed that they will participate in a fair and appropriate way in funding substantially new construction of a natural gas pipeline which will substantially reduce those prices that I've talked to you about. That will help us to save the industry in this state. As you know, many of our large industrials are actually shut down because it costs more to buy the fuel and the electricity than it does to run the plant. We can't let that continue. With this agreement they expect a swift approval by the Federal Energy Regulatory Commission and hope to have the pipeline on line, built, by the winter of 2017 and 2018. I wanted to bring you up to date, that the work we did here did mean something, and it will tremendously help the state of Maine and the people and the businesses here. Thank you, Mr. President.
