Beginning her career with the Portland Parks and Recreation Department at the Cummings Center, she worked to connect communities through youth enrichment and recreational programming. In 1986, she became the Community Services Director for the Town of Yarmouth, a position she held until her retirement in 2013. She expanded Yarmouth's public outdoor spaces, championed the preservation of the iconic "Herbie" elm tree and brought the Summer Arts Series to life. She was the second woman to serve as president of the New England Parks Association, the oldest association of its kind, and held numerous leadership roles in the Maine Recreation and Parks Association and the National Recreation and Parks Association. Ms. Noyes will be long remembered and sadly missed by her family, friends and community;
